

Planetary Emissions Management Inc.  
Radiocarbon Infrared Spectrometer (iRIS-III-III)  
Reservation Agreement

This Radiocarbon Infrared Spectrometer (iRIS-III) Reservation Agreement ("Agreement") between You ("you"), and Planetary Emissions Management Inc. (PEM Inc.), a company incorporated under the laws of the state of Delaware with a registered office at 45 Prospect Street, Cambridge, MA 02139 ("we" "our" or "us"), is for your reservation with us of an iRIS-III analyzer and any additional components as indicated on the signature page (page 2) of this Agreement. The Reservation Agreement allows you to configure your iRIS-III and initiate production. Subsequent to completion of this Reservation Agreement you will receive a link to your Order and Purchase Agreement to be finalized upon production of your iRIS-III. Under this reservation agreement: 1) there is no obligation to purchase an iRIS-III, 2) the reservation fee of \$100 is refundable at any time, and, 3) the reservation fee is credited to any future purchase. The reservation fee can be transmitted by PayPal, credit card, or by check.

### **1.Reservation and Territory**

You hereby confirm that you wish to reserve an iRIS-III with PEM Inc. and are at least 18 years of age and intend to take delivery of an iRIS-III in the United States or other country according to such laws as may pertain to the purchase of the iRIS-III.

### **2.Non-Binding Reservation Payment; No Obligation to Purchase**

The reservation payment for the iRIS-III base configuration is \$100.00 USD. In consideration of your signing and returning this Agreement to us, and upon receipt of the Reservation Payment (payable by check or electronic transfer in accordance with the payment instructions attached to this Agreement) for the iRIS-III you wish to reserve, we will, subject to paragraph 6 below, assign to you a reservation sequence position on our production line for an iRIS-III analyzer. PEM Inc. does not hold reservation payments separately or in an escrow or trust account, or pay interest on reservation payments, except to the extent required by applicable law. This Agreement does not constitute an agreement for the sale and supply of an iRIS-III. You are under no obligation to purchase an iRIS-III from us, and we are under no obligation to supply you with an iRIS-III. If and when we notify you of the availability of an iRIS-III and you wish to proceed with the purchase of the iRIS-III, such purchase will be governed by a separate and legally binding agreement ("Order and Purchase Agreement"). The Reservation Payment is fully refundable to you should you choose to abandon your reservation prior to entering into a Purchase Agreement.

### **3.Effective Date**

This Agreement will be entered into and effective between you and us when we receive this Agreement signed by you (in person or via email, fax, or by common ground carrier (USPS, UPS, FedEx) in accordance with paragraph 9 below) together with the Reservation Payment. Upon the effective date, we will activate your reservation.

### **4.Order Process**

As the start of production of your iRIS-III nears, we will ask you to confirm your option selections. We will also ask you to confirm where you will register and take delivery of the iRIS-III, and to provide full details of the legal purchaser of the iRIS-III. We will create an order for your iRIS-III detailing the information provided by you ("Order"), and a Purchase Agreement indicating the estimated purchase price of your iRIS-III, taking into account the base price of the model and any options included or that you select, plus any applicable taxes, transport and delivery charges, and any other applicable fees. We will then submit to you the Order and the Purchase Agreement. If you wish to proceed and purchase an iRIS-III, you must sign and return to us the Purchase Agreement (payment plans and financing are available – contact us for more information [info@pem-carbon.com](mailto:info@pem-carbon.com)). We will then commence production of your iRIS-III and your Reservation Payment will be held as a non-refundable deposit and applied to our production costs, pursuant to the terms of the Purchase Agreement. Approximately six (6) weeks before your iRIS-III is ready for delivery, we will notify you that we will be requesting payment of the "Amount Due from Buyer" at delivery stated on the Purchase Agreement. We will not deliver the iRIS-III to you until we have received full payment in cleared funds from you.

### **5. Deferral**

If you do not wish to enter into an Order and Purchase Agreement, you have the option to relinquish your reservation sequence position and defer to a later position to be determined by us (only one deferral is permitted). If you do not communicate your decision to us within thirty (30) business days of notification under paragraph 4, you will automatically be granted such a deferral.

## **6. Priority**

We will establish your reservation sequence position in our sole discretion. We may decline or delay reservations to avoid oversubscription or as we deem appropriate in our sole discretion. If your reservation is declined, you will be notified and your Reservation Payment will be refunded.

## **7. Your Details**

From time to time we will ask you to provide to us information so that we can perform our obligations under this Agreement. We will treat all your personal information as confidential (although we reserve the right to disclose this information in the circumstances set out below). We will keep it securely and we will fully comply with our obligations under applicable data protection or privacy law. By reserving an iRIS-III, you are giving us your consent to use your personal information and the other information that you provide to us so that we and other affiliated PEM Inc. companies can process your reservation, conduct administration and prepare the Order and Purchase Agreement. We may transfer this information to other PEM group companies (but not to third parties) for these purposes. From time to time, we and other PEM companies may contact you by mail, telephone, email, text and fax in relation to your reservation of an iRIS-III and you agree that you will not consider any of the above as being a breach of any of your rights under any data privacy, data protection or privacy law. You can opt-out of receiving marketing information from us at any time; you may contact us for more information. However, we will still use your information in order to process your reservation. You have a right to ask for a copy of your information (for which we charge a small fee) and to correct any inaccuracies.

## **8. Limitation of Liability**

We make no warranty of any kind in connection with this Agreement. Under no circumstances will we be held liable for incidental, special, punitive, or consequential damages of any kind (including lost profits) arising out of your reservation or this Agreement, even if we or our representative have been advised of the possibility of occurrences which would lead to such damages. In the event we are held liable for any damages related to your reservation or this Agreement, your sole and exclusive remedy will be limited to reimbursement of the Reservation Payment paid to us. You must bring any claim or action related to these matters against us within two (2) years of any act, event, condition or omission upon which your claim or action is based.

## **9. Execution, Governing Law and Jurisdiction**

This Agreement can be validly executed by email, fax or common ground carrier (USPS, UPS, FedEx). A signed copy of this Agreement will be deemed to have been properly received by us (i) twenty-four (24) hours after an email is sent, (ii) the next business day following the date of fax with proof of successful transmission, or (iii) upon receipt from a common ground carrier. This Agreement will be governed by Massachusetts law, and you and we both agree to the non-exclusive jurisdiction of the Massachusetts state and federal courts.

## **10. Draft of your Order and Purchase Agreement**

Upon receipt of the Reservation Agreement and payment of the reservation fee we will send you a pre-acceptance draft of the Order and Purchase Agreement that you may reserve and transmit to PEM at any time. The Order and Purchase Agreement does not represent an obligation of any kind to purchase an iRIS-III. If the Order and Purchase Agreement is not executed it will lapse without consequence within six (6) months.

## **11. 12 Month, Equal Payment, No Interest Financing**

A limited number of 12-month payment plans (equal monthly payments, no interest) are available to reservation holders. The plan is subject to credit approval. There is no obligation to accept this plan. Outright purchase or other payment options may be considered at any time. Final terms will apply as part of the Purchase Order process. 


